Captain Zarcone and Jackie,

I received a call today from the head of the Fifth Avenue BID in New York.

All the BIDs are meeting with Commissioner Bratton on Monday – and one of the topics will be the problems they are having with the characters in Times Square.

I certainly commiserated with him, and told him to say hi to the Commish. All of this will sound quite familiar to him.

Currently one of the strategies they are pursuing involves the intellectual property piece — and I told him that we have tried this angle on several occasions, with little result. However, I did share with him the one time it "stuck" and that was when Sesame Street had plans to open a pop-up store at H/H one summer, and they wanted to clear out of the way the slimy characters so as not to confuse the visitors. Fortunately we saved these letters.

There is talk of bringing together some pro-bono attorneys to tackle this strategy in New York. I told him we would stand in solidarity on any of these strategies and to keep us informed.

I am forwarding two cease and desist letters that were presented to two of the characters that we know of back in 2009. As I mentioned to you, this was in anticipation of a pop up Sesame Street experience at Hollywood & Highland that summer.

After the pop up was over, eventually the characters came back.

This is the only time we have seen a successful application of this type of license enforcement.

I am going to go back into my archived email to see if I can find our communications (with Sesame Street) about this.

Let me see if I can find anything else along these lines as well. I know that LAPD and our city attorney attempted also to meet with Warner Brothers and Marvel Comics. That did not yield much in the way of action.
