We have been working closely with our LE partners to determine the route of the group on Thursday and have found the following information. Please note this information is subject to change without notice. As you can imagine based on the groups involved they do not freely communicate with Law Enforcement.

Start: 100 West First Street Los Angeles Ca in front of LAPD HQ

Assembly Time: 1:30 pm

March Time: 3:30 pm

Ending Time 5:30 pm

Estimated participants 200 / A contingent was sent to New York as it is a national day of action.

No Planned Civil Disobedience

Rally with bullhorns and portable sound system at 100 W. First Street in front of LAPD HQ, on South Side of the street. Handheld banners, signs. No vehicles allowed.

Route expected to be followed:

Start - 100 West First Street / LAPD HQ

South on Spring Street to 5th and Spring. Stop for 5 -10 minutes.

East on 5th Street to Los Angeles Street.

Left (North) on Los Angeles Street to Winston.

Right (east) on Winston to Wall Street. Left on Wall Street to 4th Street.

Right (East) on 4th Street to San Pedro. Stop for 5 -10 minutes.

South on San Pedro to 5th Street. Stop for 5 -10 minutes at Sth and San Pedro.

Right (west) on 5th to San Julian.

Left on San Julian, go two blocks South to 7th Street.

West on 7th Street to Wall Street.

Right (North) on Wall Street to 6th Street. Left on 6th Street. Stop 5 minutes.

Right on Maple 1 Block West to 5th Street. Right on 5th Street to Wall Street.

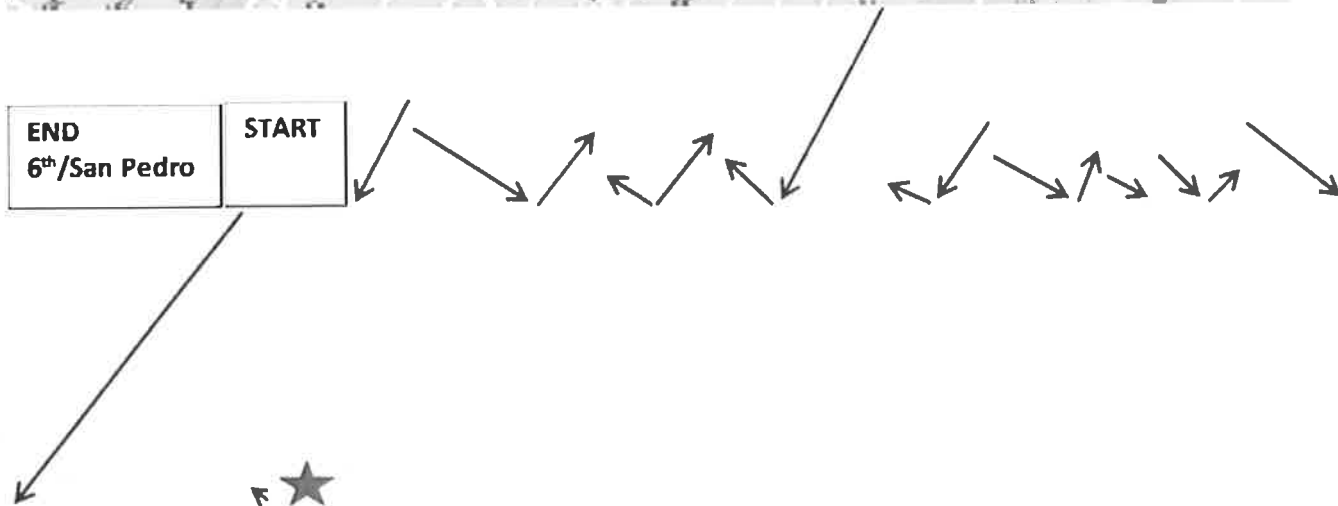
Stop for 5 minutes.

East on 5th to San Pedro.

South on San Pedro to 6th and San Pedro. Stop at 6th and San Pedro for 10-15-minute final rally.

Disperse from 6th and San Pedro.
