20 The Court has reviewed with Joint Notice of Tentative Settlement, Request  
21 to Vacate the Trial Date and for the Court to retain Jurisdiction to Complete  
22 Settlement submitted by the parties on December 2, 2015. The docket in this  
23 action reflects the results of the settlement conference conducted by Magistrate  
24 Judge Woehrle on November 24, 2015.

25 The Court is informed that the settlement requires a four-step approval  
26 procedure by the City, as outlined in the Joint Notice, that is anticipated to take  
27 several months to complete.

28 The Court is further informed that, if the settlement is approved, it will be  
paid at the beginning of the next fiscal year, which is July 1, 2016.

1 Accordingly, the Court vacates the current scheduling order to permit the  
2 settlement to be considered by the defendant City. The parties are to notify the  
3 Court of the outcome of the settlement review as soon as it is completed and to  
4 provide a status report on the progress of approval of the settlement no later than  
5 March 31, 2016 if a notice of completion of settlement has not been filed before  
6 that date.


