We have reviewed the application for exemption from tax of the above named organization under Section 23701e of the Revenue and Taxation Code. However, before your application can be processed, the items listed below are required:

1. The organization was incorporated on 10/31/2001 and based on our records; the Form 199 *California Exempt Organization Annual Information Return* was not filed for taxable year ending (TYE) 12/2004 - 12/2006. We need to verify the organization's Receipts & Expenses Statements for TYE 12/2004 - 12/2006 and determine if the organization was required to file the Form 199 for those taxable years. Thus, provide a copy of Receipts & Expenses Statements for TYE 12/2004 - 12/2006
2. Our records indicate that the Form 199 *Exempt Organizations Annual Information Return* was filed for taxable year ending (TYE) 12/2012 and 12/2014, but filing fees were not paid. Generally, if you file Form 199, you pay a filing fee with the return. The amount depends on when you file, and when you make the payment.
