- During daily OHS Patrol WPD Officers Miller & Metcalf are requested by LAPD.

REPORT

At approximately 0830 hours on February 23rd, 2016, Watershed Protection Division (WPD) Officers Miller and Metcalf arrived at the incident location: 544 Towne. WPD Officers processed the encampment, removing health hazards. Various trash and debris were located and disposed..

1st Location: 544 Towne

1. Roque, Salvador

(DOB 1-13-1962) Misd. Warrants. WPD called to address where two tents had been cordoned off after arrest. Both tents had drug paraphernalia, soiled clothes and bottles of urine. About three dozen articles of clothing were deemed salvageable. Personal papers saved. Meds (sleeping pills) saved. Items that were stained were disposed. One of the tents was ripped and was discarded. Two bags of personal belongings saved. Two blankets saved. Other saved items included bag of quarters, clothes, t.v., shoes, toiletries, tent. LAPD Sgt. Jack Richter informed 2nd location 3 feet away also belonged to Roque. 2nd tent disposed, remove 15 syringes, pornographic materials and other stained, contaminated items.

All containers and plastic bags containing personal property were labeled and transported by LAPD to a storage facility provided by LAPD.
