I would like to add my voice to this chorus. Things feel like they've gotten out of control with this lot, and it seems to be escalating daily. I counted 12 people set up in the lot on Tuesday night at 10:00pm, and that's not counting whoever/however many people were posted up in the near-professional grade encampment that appears daily in the back left corner. I agree that this seems like something that should fall under the purview of the Housing Authority, at least during the hours that they have security monitoring the lot.

Over the past several years, I feel like LB has made huge strides in changing downtown into a desirable area to visit, patronize, and live, and this issue is undermining a tremendous amount of hard work and forward progress. I regularly hear customers and residents comment that they don't feel safe downtown, and in our area, it all seems to come back to this parking lot, as ground zero.

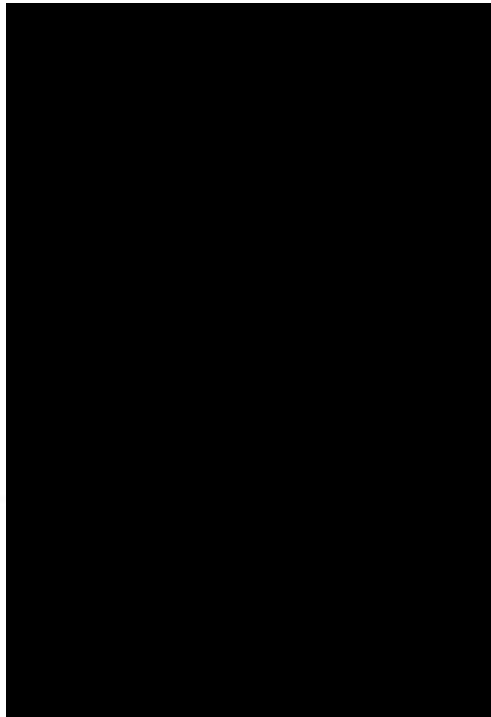

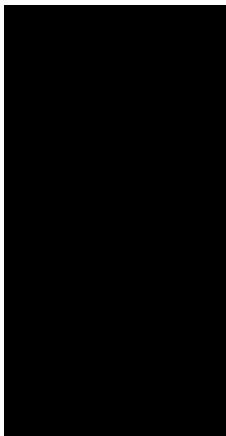

Mark, Teresa, et al,

Thank you for including DLBA in your email. This location has been an ongoing concern for us as well. As you may know, our guides have monitored this site and others in the late evening for several weeks now and we have shared those numbers with HHS and LBPD on occasion. The number of "campers" has averaged between 6-10 during this time.

Our guides engage the individuals on a nightly basis, asking them to leave the private premises. However, they have refused to leave, so our guides contact LBPD for further assistance. In early March, we added two additional guides from 7:00 am to 3 pm on weekdays to visit hot spots throughout our PBID area of Downtown, offering information to individuals before asking them to leave the premises.

Recently, I spoke with the property manager (Atlantic Property Management) of 150 Long Beach Blvd, who expressed the same frustration with the recurring problem and informed me that in addition to calling police, they have hired pressure washing on a regular basis to address cleanliness and disrupt the nightly routine. Unfortunately, it has not stemmed the growing number of overnight campers. They also indicated that night security is cost prohibitive and BofA would be unwilling to shift their daily security to an evening shift.

I offered to communicate their concern and activities to LBPD and the CD2 Council office and share contact info for both as well. Additionally, I will be sending the rep a Private Person Arrest (PPA) form and will share it with LBPD upon completion.

Our guides engage the individuals on a nightly basis, asking them to leave the private premises. However, they have refused to leave, so our guides contact LBPD for further assistance. In early March, we added two additional guides from 7:00 am to 3 pm on weekdays to visit hot spots throughout our PBID area of Downtown, offering information to individuals before asking them to leave the premises.

Recently, I spoke with the property manager (Atlantic Property Management) of 150 Long Beach Blvd, who expressed the same frustration with the recurring problem and informed me that in addition to calling police, they have hired pressure washing on a regular basis to address cleanliness and disrupt the nightly routine. Unfortunately, it has not stemmed the growing number of overnight campers. They also indicated that night security is cost prohibitive and BofA would be unwilling to shift their daily security to an evening shift.

I offered to communicate their concern and activities to LBPD and the CD2 Council office and share contact info for both as well. Additionally, I will be sending the rep a Private Person Arrest (PPA) form and will share it with LBPD upon completion.

Mark, Teresa, et al,

Thank you for including DLBA in your email. This location has been an ongoing concern for us as well. As you may know, our guides have monitored this site and others in the late evening for several weeks now and we have shared those numbers with HHS and LBPD on occasion. The number of "campers" has averaged between 6-10 during this time.

Our guides engage the individuals on a nightly basis, asking them to leave the private premises. However, they have refused to leave, so our guides contact LBPD for further assistance. In early March, we added two additional guides from 7:00 am to 3 pm on weekdays to visit hot spots throughout our PBID area of Downtown, offering information to individuals before asking them to leave the premises.

Recently, I spoke with the property manager (Atlantic Property Management) of 150 Long Beach Blvd, who expressed the same frustration with the recurring problem and informed me that in addition to calling police, they have hired pressure washing on a regular basis to address cleanliness and disrupt the nightly routine. Unfortunately, it has not stemmed the growing number of overnight campers. They also indicated that night security is cost prohibitive and BofA would be unwilling to shift their daily security to an evening shift.

I offered to communicate their concern and activities to LBPD and the CD2 Council office and share contact info for both as well. Additionally, I will be sending the rep a Private Person Arrest (PPA) form and will share it with LBPD upon completion.

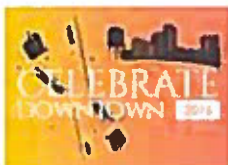

Residents walking through the area at night report seeing drinking and drug use.
2. 6<sup>th</sup> Street and San Francisco. There has been a person living out of his car (picture and license plate # included in the attached email) at 6<sup>th</sup> and San Francisco for some time now. Recently more persons have made an encampment in the area. Reports include drinking and possible drug activity. Descriptions for the individuals are included in the attached email.

Today I took a ride down to Cesar Chavez park and saw a homeless camp behind Hoonigans shop off 7th st. It is not the first time I've noticed this group -- The grey car and individuals camped out in this area have been here for several weeks. I provided them (5 males) the pocket guide resource directory, but they didn't seem interested. Attached are a few photos of the area. As you can see, a lot of trash is building up and I've seen (separate occasions) them walking around half naked ( boxers, no shirt ). Please keep in mind there are children in the neighborhood walking around the park and school and feel it is not a visual our children should be exposed to. The area the homeless are camping out makes it look less safe for the community and becoming concerned more will come to "stay".

The description I was able to gather on each male is as follows: Gentleman in grey vehicle, is African American male about 6 ft. tall in late 40s/early 50s. Two gentlemen in blue tent were two Caucasian males, 1 is under 6 ft, early 50s med/heavy set bald. 2nd had brownish hair, 5'7ish late 40s. Hispanic male, long brown hair about 5'5 tan skin. The last gentleman I could not describe because he was laying down.

Please let me know what steps we can do to assist these individuals and maintain the area around the parks and schools clean and safe for everyone.
