Dear Yena:

The Hollywood Media Bid would like to request a meeting with Councilmember Ryu regarding the impacts of Recreational Vehicle parking (Motor Homeless Vehicles) within the Hollywood Media District BID. While there are some restrictions in force there has been a tremendous surge of motor homeless vehicles within the business improvement district. There has been little to no enforcement of these vehicles. Tenants along with management have reported these vehicles DOT for enforcement without any action. We are requesting the Councilmember's support and assistance in coming up with a viable enforcement plan. These individuals are extremely aggressive and have taken over the public right of ways with cones, chairs, generators, and even laundry. On occasions when I have physically stopped Parking Enforcement on the street they have stated that they are

on their street sweeping routes - they are not marking for 72 hours. Even then the RV's move ever so slightly to negate the traffic officers chalk marks.

At your earliest opportunity, please provide two dates in which the Councilmember and DOT will be able to meeting with our Board members prior to year end. It would be very educational for the Councilmember to do a drive a round with our Board Members of the BID.
