Hi Kerry,

Unless the property has a Conditional Use or some other Planning action that prohibits live entertainment, City Planning would not have any issue live entertainment in a commercial zone. They would likely have to get some type of clearance from LAPD though.

As for alcohol, if the property does not have the right to sell alcohol, they can get a "one-day permits" or caterer's permit (not exactly sure of the name) from ABC. Non-profits do this often.

I want to make sure LAPD is aware of this community event, and that we also can earmark additional BID Patrol over that time. Steve, you and I can look at where the slack is in both budgets, as this spans two BIDs.

This festival is intended to present a neighborhood "night-life" experience in Hollywood. We are trying to change the image of Hollywood by celebrating the authentic music and artistic options that are here. As such, the BID is "curating" over four days/nights dozens of different musical experiences, acts, pop-up art shows, comedy, etc – and inviting the the public in to experience Hollywood as a walkable neighborhood. No tickets are being sold. Most venues will offer free entertainment, and others will sell tickets as usual.

The activity is largely going to be centered around Selma and Cahuenga - very little will happen on Hollywood Blvd.
