1 Synopsis

1. In March 2016, property manager Bryan Kim worked with Los Angeles City Council District 13 field representative Aram Taslagyan to clean up some homeless encampments around Kim’s properties. While City laws and procedures were followed for most of these cleanups, Taslagyan seems to have organized at least one of them contrary to law and procedure. It appears that Taslagyan did this because Kim needed the area clean immediately due to an impending property inspection. This constitutes a violation of LAMC 49.5.5(A) by Taslagyan.

2 Background

2. Sean Starkey was an intern at Los Angeles City Council District 13 (“CD13”) in March 2016. Aram Taslagyan is a CD13 field deputy. Mitch O’Farrell is the Councilmember for CD13.
3. Bryan Kim is a property manager who handles some properties in CD13.

3 Laws

4. The Los Angeles Municipal Code at §49.5.5(A) states in part that:

City officials, agency employees, . . . shall not misuse or attempt to misuse their positions . . . to create or attempt to create a private advantage or disadvantage, financial or otherwise, for any person.

4 Facts

5. On March 8, 2016, Bryan Kim talked to Sean Starkey about cleaning up some homeless encampments in CD13. Evidently their phone call was disconnected and they continued their conversation via email. In this email exchange Kim asked Starkey:

Can you please forward the policy and procedure documentation along with the timeline for clearing the homeless from the discussed area?

Starkey replied:

Below is [sic] the steps we go through with all homeless encampments. There is not a specific timeline for the process. It all depends on each agency. . . .

- Reported to BSS²
- BSS assigns investigator to the site who visually inspects the site
- BSS contacts LAHSA³

- LAHSA conducts outreach and offers services
- LAHSA makes second visit
- LAHSA signs off
- Public Works signs off
- Sanitation allocates days to Council Offices
- Sanitation posts at the site 72 hours prior
- Council Office coordinates LAPD

6. That Starkey’s description of the process is accurate is confirmed by the Department of Sanitation’s Standard Operating Procedure (“SOP”) for cleaning sidewalks in compliance with LAMC 56.11.⁴ The SOP was developed by the Department of Sanitation in compliance with the City Council’s mandate that it:

promulgate rules, protocols and procedures for the implementation and enforcement of this ordinance [LAMC 56.11], consistent with the provisions herein.

The SOP was reviewed by the City Attorney and found to conform with the ordinance. The relevant pages can be found in Exhibit 2 (page 12).⁵

7. In particular, Step #6 in the SOP for homeless encampments elaborates on the 72 hour posting requirement, which is actually a 24 hour posting requirement, stating that:

a notice will be posted at the clean-up location a minimum of 24 hours in advance of the clean-up date/time . . . The posted notice shall be photographed by LASAN to document the notification of the pending clean-up. The Notice shall be valid for only 72 hours from posting. If the encampment clean-up cannot commence within 72 hours from posting, then a new posting must re-occur before the clean-up may commence.

See Exhibit 2 (page 12).

8. On March 9, 2016 Kim set up a meeting for March 11, 2016 with Aram Taslagyan at the CD13 district office. He asked to meet with Mitch O’Farrell at this time, but Taslagyan said that O’Farrell was not available. See Exhibit 3 (page 16). On March 10, 2016, Kim asked Starkey via an email related to this meeting:

What would be the next available meeting with Councilmen [sic] O’Ferrel [sic] be re: homeless encampment on Vermont/Monroe Ave?

See Exhibit 4 (page 18).

9. This meeting seems to have taken place as scheduled at 9:30 a.m. on March 11 at the CD13 district office. See Exhibit 5 (page 20).
10. Between March 15 and March 18, Aram Taslagyan and the LA Bureau of Sanitation (“LA San”) exchanged at least 20 pages of emails organizing the cleanup of encampments on the 700 block of North Vermont Avenue between Monroe Street and Marathon Street (see map at Exhibit 6, page 22, see email exchange at Exhibit 7, page 24). On March 21, 2016, Richard Young of LA San emailed a long list of his colleagues to confirm the March 22 cleanup locations. He specifically noted that the entire 700 block of North Vermont was posted on both sides of the street. See Exhibit 8 (page 45).
11. On Tuesday, March 22, 2016 at 5:41 p.m., after the cleanup took place, Bryan Kim emailed Aram Taslagyan, stating (see Exhibit 9, page 48):⁶

Aram,

Good to see you briefly today.

Vermont is cleared but they all moved to Marathon St.

If we can work together to relocate them off Marathon St. that would be great. As tenants have made complaints and neighboring groups are gravely concerned.

LAPD had two open incident requests under same ticket and should be visiting by tomorrow.

Further, the la housing authority emergency evacuation group said they will be making way this week offering relocation assistance.

Let’s see what we can do together.

I will call you tomorrow to touch base and share thoughts.

Thanks very much.

12. On Tuesday, March 22 at 5:49 p.m. Aram Taslagyan replied (see Exhibit 9, page 48):

Hi Bryan

Nice to see you as well.

I’ll make sure both marathon and Monroe are posted as well next time

13. On Tuesday, March 22 at 11:21 p.m. Bryan Kim replied (see Exhibit 9, page 48):

Hi Aram,

Appreciate it, thank you very much. Happy to help, will share insight tomorrow.

Fyi As there is a property inspection this Friday,⁷ if we can do what ever it takes for a removal this Thursday⁸ on Marathon and Vermont. Attached is a pic on Marathon.

This is very important we work towards a resolve as timing is key.

14. On Wednesday, March 23 at 9:48 a.m. Bryan Kim emailed Aram Taslagyan (see Exhibit 10, page 52), stating:

Good morning, Aram,

Just to share an update from this morning.

The concentration of homeless tents have diminished and it looks like it spread out on North end of Marathon.

...

15. On Wednesday, March 23, 2016 at 11:59 a.m. Aram Taslagyan emailed Bryan Kim (Exhibit 11, page 54):

Hi Bryan,

It's all clean now. We will continue to monitor the area, as will LAPD.

Please let me know if it starts up again at any level.

5 Conclusions

16. The City of Los Angeles has an official process for cleaning up homeless encampments that takes a theoretical minimum of 24 hours to carry out (Paragraphs 6, 7). The staff of CD13 understands the details of this process (Paragraph 5).

17. On or before March 8, 2016, Bryan Kim began discussions with CD13 field deputy Aram Taslagyan about cleaning up homeless encampments on N. Vermont Avenue (Paragraphs 8, 9). It took until March 22, 2016 for Taslagyan to arrange this cleanup. The process involved dozens of emails among Taslagyan and various LA Sanitation employees (Paragraph 10).
18. On the afternoon of March 22, after the policy-compliant cleanup took place, Kim told Taslagyan that the homeless people had moved around the corner to (an unposted area on) Marathon Street (Paragraph 11). Taslagyan’s reply implies that there was nothing to be done at that time but in the future they would post notice of cleanup on Marathon Street to prevent this from happening again (Paragraph 12). This is a tacit acknowledgement that it was not within policy to clean up the relocated encampment on Marathon Street without beginning the lengthy process over again.
19. Late on the night of Tuesday, March 22, 2016, Kim told Taslagyan that it was extremely important to him that the relocated encampment on Marathon Street be cleaned up before Friday, March 25, as he had an impending property inspection (Paragraph 13). Thus the cleanup of the relocated encampment on Marathon Street would constitute a private benefit for Kim.
20. At 9:48 a.m. on Wednesday, March 23, according to Kim, the homeless encampment was still present on Marathon (Paragraph 14). At 11:59 a.m. on Wednesday, Taslagyan told Kim “[i]t’s all clean now.” (Paragraph 15). Since it is not possible to arrange a policy-compliant encampment cleanup in fewer than 24 hours, this cleanup was in violation of City policy. Thus Taslagyan misused his position to arrange it.
21. Thus Aram Taslagyan intentionally (Paragraph 18) misused (Paragraph 20) his position to create a private advantage (Paragraph 19) for Bryan Kim. This constitutes a violation of LAMC 49.5.5(A) (Paragraph 4).

6 Requested action

22. I ask the City Ethics Commission to investigate whether these actions constitute a violation of LAMC §49.5.5(A) on the part of Aram Taslagyan and, if they do, to see that he’s held responsible for his actions.

7 Other considerations

23. On March 9, 2016, at the beginning of the episode described here, Bryan Kim asked Aram Taslagyan and Sean Starkey to set up a meeting with him, Mitch O’Farrell, and “another party to see what we can contribute and help to work together” (see Exhibit 12, page 56). It seems likely from subsequent emails that this other party was Lawrence Han (see e.g. email in same chain dated March 17 cc-ed to Han, Exhibit 13, page 58). On Friday, March 25, after the episode described here, Kim arranged for a

lunch with him, Aram Taslagyan, and Lawrence Han (see Exhibit 14, page 60). This lunch took place on March 29 from 12:30 p.m. to 1:30 p.m. (see Exhibit 15, page 62).

24. At 3 p.m. on March 29, after the lunch with Taslagyan and Han, Bryan Kim emailed Aram Taslagyan, stating: “FYI we would like to also give a contribution to your office to support your helpful services. Is there anything we should know about? (See Exhibit 16, page 64). The fact that Kim made this offer after a lunch at which Lawrence Han was present in conjunction with the fact that Kim was discussing Han in the context of contributions on March 9 make it at least plausible that Kim and Han were offering money in exchange for encampment cleanup. Taslagyan passed the issue off to Jeanne Min, Mitch O’Farrell’s chief of staff, telling Kim: “I am copying our chief of staff, Jeanne Min, who is better suited to answer your question.” (See Exhibit 16, page 64). Kim subsequently asked Min if she had time for a phone call and Min said that she was happy to and that she would be in touch (Exhibit 16, page 64).
25. I don’t have any more evidence relating to campaign contributions and this whole episode, and if there is more evidence, it’s not likely to be part of the public record and is therefore beyond my investigative reach. It’s possibly not beyond the reach of the CEC, though, which is why I’m bringing it to your attention.

8.2 Exhibit 2 – Department of Sanitation Standard Operating Procedure for Cleaning Homeless Encampments

INTRODUCTION

The City of Los Angeles is responsible for the maintenance of sidewalks and other public areas owned, managed or maintained by the City. These public areas must remain safe, clean, sanitary and accessible for public use by all individuals. To promote general public health and safety of all public areas, while balancing the needs of the City's population, at all levels, the City recently made amendments to the City of Los Angeles Municipal Code (LAMC) 56.11 to regulate any personal property disposed, left or stored in public areas.

These protocols outline the operating guidelines, designation of tasks, and scope of work for regulating the storage of personal property in public areas and the allowance for the impoundment of such property, after the provision of notice, as provided for in LAMC 56.11.

BACKGROUND

LAMC 56.11 regulates storage of property on the City's public right-of-way, defined by LAMC 56.11 as including sidewalks, alleys, and streets. The Ordinance's Declaration of Legislative Intent states, in part, that the unauthorized use of public areas for the storage of personal property interferes with the rights of other members of the public to use public areas for their intended purposes and can create a public health or safety hazard that adversely affects residential and commercial areas. The purpose of LAMC 56.11 is to maintain public areas in clean, sanitary and accessible condition for all.

DESIGNATED ADMINISTRATIVE AGENCY, LAMC 56.11.11

Los Angeles Sanitation (LASAN) serves as the Designated Administrative Agency ("DAA") under the ordinance. The DAA shall promulgate rules, protocols and procedures for the implementation and enforcement of this ordinance, consistent with the provisions herein. The DAA is authorized to make administrative and ministerial revisions to these protocols, and/or forms and posting notices as needed to address unanticipated scenarios or any amendments to LAMC 56.11 or applicable codes or statutes.

CITY ATTORNEY REVIEW

The City Attorney's Office has reviewed the following LAMC 56.11 protocols for conformity with the Ordinance and subsequent amendments.

PROCEDURE #2 – Homeless Encampment Clean-up Authorization

Upon data entry, a Homeless Encampment clean-up authorization number is created and assigned to the designated location. The following process must be completed in order for full approval of the authorization to commence the clean-up operation.

LEAD DEPARTMENT: LASAN

PRIMARY SUPPORT: LAHSA or OHSP

SECONDARY SUPPORT: LAPD, BSS, GSD, LADOT, RAP

Homeless Encampment Clean-up Authorization Protocol

Step #1 – REFERRAL: LASAN will initiate the Homeless Encampment clean-up authorization process by verifying the encampment and its location including City owned, managed, or maintained property, and by taking photographic evidence of the location. LASAN will then submit the information into a Homeless Encampment data management system. The required information fields consist of, but are not limited to the following:

1. Address and/or cross street locations of the homeless encampment (or closest address);
2. Description of the encampment(s), including photographs of the encampment;
3. Additional location description (i.e. alley, under bridge, on overpass, etc.),
4. Date location visited /assessed.

Step #2 – LAHSA AUTHORIZATION: Outreach to the homeless individuals in the area will be conducted by the Los Angeles Homeless Services Authority (LAHSA) or Other Homeless Service Provider (OHSP) to inform the homeless residents of the upcoming clean-up efforts and the requirement to relocate both themselves and their possessions from the clean-up areas prior to the clean-up date/time. During these visits, LAHSA or the OHSP shall offer available assistance and social services to the homeless in the designated area. Upon completion of the visits, LAHSA will sign off on the authorization.

Step #3 – LASAN – CHIEF ECO Authorization: Once LAHSA or OHSP has signed off, the authorization shall be reviewed and approved by the LASAN –Chief Environmental Officer, or his/her designee.

Step #4 – BOARD OF PUBLIC WORKS AUTHORIZATION: The President of the Board of Public Works or designated commissioner shall review and approve the clean-up. The authorization is valid for up to 90 days from BPW approval or through completion of the clean-up at the location, whichever comes first.

Step #5 – HOMELESS ENCAMPMENT CLEAN-UP SCHEDULING: LASAN shall program and schedule encampment clean-ups.

Step #6 – NOTICING: As required in Procedure #3, a notice will be posted at the clean-up location a minimum of 24 hours in advance of the clean-up date/time (See Appendix 1). The posted notice shall be photographed by LASAN to document the notification of the pending clean-up. The Notice shall be valid for only 72 hours from posting. If the encampment clean-up cannot commence within 72 hours from posting, then a new posting must re-occur before the clean-up may commence.

Step #7 – DOCUMENTATION: The Designated LASAN Employee overseeing the clean-up shall document the clean-up, health hazard assessments and impounded property.
