The Pacific Palisades Business Improvement District ("BID") has received and reviewed your California Public Records Act request dated January 14, 2017. Attached are the BID's agenda and minutes for its Board and committees for 2016.

With respect to your request for "any message to/from/cc/bcc any address at lacity.org or any of its subdomains," I am in the process of searching for all non-exempt, non-privileged disclosable public records in possession of the BID responsive to your request for emails "to/from/cc/bcc any address at lacity.org," but I will require an additional fourteen (14) days because of the breadth and scope of the request to identify these records. To date, I have determined that certain records are exempt from disclosure because they fall within the deliberative process privilege under California Government Code § 6255(a), and some will be redacted because they contain personal contact information that would constitute an unwarranted invasion of personal privacy (San Gabriel Tribune v. Superior Court (1983) 143 Cal.App.3d 762; Braun v. City of Taft (1984) 154 Cal.App.3d 332; Wilson v. Superior Court (1996) 51 Cal. App. 4th 1136; Cal. First Amend. Coalition v. Superior Court (1998) 67 Cal. App. 4th 159; Eskaton Monterey Hospital v. Myers (1982) 134 Cal.App. 3d 788) and the benefit of disclosure would not outweigh the public benefit in non-disclosure. See Cal.Govt.C. § 6255.

With respect to your request for "any message to/from/cc/bcc any address at lacity.org or any of its subdomains," I will need further clarification as to the meaning of the expression "or any of its subdomains." Upon receipt of that clarification, I will be better able to determine whether such records are discoverable under the California Public Records Act.
