Dear Holly,

For some reason no one in your office will give me a copy of the mailing list used to send out the petitions for the Venice Beach BID. As you can see, Rita tells me to contact Tara Devine and ask her for this list (which I did, although I don't know why she would answer me, which she hasn't).

Probably you're aware that CPRA specifically does not require that a local agency own or possess a record for it to be disclosable. In particular, the law states explicitly that records that are "used" by local agencies in the conduct of the public's business are public records. The very same section of the statute mentions records that are owned or possessed by the agency, so it's abundantly clear that the legislature did not mean the word "used" to act as a synonym for "owned" or "possessed."

This mailing list is clearly used by the City to accomplish its purpose of establishing this BID. If it were possible for the City to avoid disclosing records via the stratagem of leaving them in the hands of private parties to use them on at the City's behest then CPRA would have essentially no force at all. Hence Rita's argument, that you all don't have the list, is unsound.

Please also note that CPRA states explicitly that all of its exemptions are voluntary and unbinding on your part. The law explicitly allows you to release this information because you think it's the right thing to do, even if you hear some arguments against doing so. If you're inclined to delay, I hope you will consider taking this route rather than, e.g., asking the City Attorney what to do and waiting weeks for their answer.

The list won't be of much use to anyone after August 23, so I really hope you can intervene in this process and send a copy to me promptly, as the law requires.

It's my understanding that the BID formation process was initiated by the City, which means that the list was used to further the City's purpose in establishing this BID, making it a public record. One last thing. The Clerk's own outline on BID formation (attached for reference) says that if proponent groups are too broke to hire a consultant and don't want the City to pay for a consultant, the Clerk's staff will act as a consultant. In such a case clearly they will produce a list, and clearly that list will be a public record. Thus the creation of such lists serves some purpose of the City's, otherwise why would they ever do it? If some lists serve the City's purposes then they all do, including this one, so it's a public record.
