1 TO THE HONORABLE COURT AND THE CLERK OF THE COURT:

2 Defendants City of Los Angeles and Plaintiffs Los Angeles Catholic
3 Worker, Cangress, Harry James Jones, and Louis Grady, Lloyd Hinkle, through
4 their respective counsel of record, provide this Court with a report of the status of
5 the pending settlement in this action.

6 As the parties previously apprised this Court, the parties reached a tentative
7 settlement agreement on April 5, 2016, and have been diligently working to
8 finalize all terms necessary to reach a full and final settlement of the case. On
9 December 8, 2016, the parties apprised this Court that the parties had agreed to all
10 terms of the settlement. However, on November 2016, Plaintiff Walter Shoaf
11 passed away before the final agreements were executed, and this Court substituted
12 his son, Wanari Shoaf, as Plaintiff in this action on January 26, 2017.

13 The final agreements have now been signed by all parties. A proposed
14 Stipulated Judgment between Plaintiffs and Central City East Association will be
15 filed concurrently with this report. The final settlement between the City of Los
16 Angeles and Plaintiffs must be given final approval by the City Council. The City
17 expects that the settlement will be considered and approved within the next 45
18 days.

19 The City will file a status report within 45 days, or April 25, 2017 if the final
20 request for dismissal has not been filed by that time.
