

This post is what the Skid Row NC is. If you live in the Historic Core, Little Tokyo, and the Fashion District, this will absolutely affect you and you might actually be in the new NC if approved.

It has come to my attention that people don't even know that there is a possibility of the Neighborhood Council breaking up and that they might be affected. The head of the Fashion District BID just found out last week that parts of the BID is in the possible new NC. There was supposed to be outreach about this kind of thing before it gets approved, but that outreach was very selective. There is also a huge failure by the leadership in DLANC to even let people know that there is an election on April 7th to possibly split the NC.

The Skid Row NC has proposed boundaries of Main to 3rd to 7th to Alameda. So if you live in the Mercantile Lofts, Pacific electric lofts, and San Fernando lofts, you will be in the New Neighborhood Council. And all decisions about businesses and buildings on Main and Los Angeles will be made by this new neighborhood council. The Nickel Diner, Coles, Las Perlas, the Regent, and any new place planning to open along with teh Little Tokyo Galleria will be under the control of the SRNC.

The Bylaws of this new NC is specifically written so that the people who created it will always have power. There are 11 total seats. 5 of them are residents but only 2 of the resident seats are allowed to be people who live in market rate housing. The other 3 are reserved for low income or homeless residents. There is only one seat for business and it can be for someone who owns or works in the district. The remaining seats are for a Arts and Culture Member, At-Large Member, Social Service Provider/Faith Based Member (2) and Community Advocate/Social Justice Board Member.

There is also a special carve out for General Jeff: "Founder Emeritus: General Jeff is acknowledged to be the Founder Emeritus of the Skid Row Neighborhood Council and is authorized to speak on all issues affecting the SRNC, recognizing that the Executive Committee will have the final word on all policy issues

and also recognizing that the Board President is the official spokesperson for the Council."

I encourage everybody in the Fashion District and Historic core to read the bylaws (link below). In order for the Skid Row NC to form, it needs to get 50% in the proposed boundaries, 50% of the Historical Cultural NC boundaries, and also 50% of the people who live in the DLANC boundaries. So literally every person who lives in DTLA can vote on this and should consider the implications of a Skid Row Neighborhood Council being formed.

Simon Ha The way I see it, the high concentration of poverty will not be diluted unless we start making Skid Row a mixed income community. I assume there's a great deal of concern of losing affordable housing and SRO's and displacement if market rate housing is allowed in SR. The existing housing has to remain affordable for 50+ years typically from when they are first occupied. We will continue to build permanent supportive housing in the area but concurrently, we need to build more housing for the workforce and market rate to reach for a balanced neighborhood. Skid Row is part of Downtown and needs to be integrated in the bigger vision, not isolate itself. I think if the residents and stakeholders in the area feel their concerns aren't being address by DLANC, Little Tokyo, and HCNC, they have a right to form their own NC. 

Jacob Douglas Van Horn Here is my take. Let me start by saying this is my personal opinion and does not indicate any official position of the Downtown Los Angeles Neighborhood Council. The purpose of a Neighborhood Council is so that the stakeholders in a neighborhood are empowered to have their collective voice heard by the city of Los Angeles through their elected representatives. It allows everyone in a community to participate and make local politics more accessible to them.

Skid Row is currently represented under the Downtown Los Angeles Neighborhood Council which also represents the Historic Core, Fashion District, South Park, and Bunker Hill/Civic Center neighborhoods. The feeling by the Skid Row Neighborhood Council formation committee is they are not best served by voting along with representatives from these areas and need their own council. They have submitted an application to the Department of Neighborhood Empowerment to bifurcate into their own council with the existing Skid Row district along with portions of the Historic Core District, the Fashion District, and Little Tokyo (which is under the Historic Cultural Neighborhood Council) What may surprise some people is I believe they may be correct in that those stakeholders need and deserve their own voice.

That being said I can not support the formation of this council and urge stakeholders to vote no. Here is my reason. Each formation committee write the bylaws which will govern the council should it be formed and determines how the community will be represented. It is the responsibility of each formation committee to do outreach to the stakeholders that will be affected so they are aware of the process and can choose to be a part of it. Outreach was done by the committee but only to a very select group of people. I have had countless stakeholders reach out to me in dense buildings with thousands of stakeholders along Main Street, in Little Tokyo, and in Central City saying they were never informed or consulted in the plan to let them have their own voice and chart their own destiny. Every council has the responsibility to include and represent everyone. That is what democracy is and what we have in the

current bylaws are not.

Skid Row is a diverse community that contains every type of stakeholder imaginable. There are SRO occupants, market rate residents, the homeless, business owners, property owners, and social service providers. It is going to take the joint efforts of every single type to address the difficult problems this community faces on a daily basis. Democracy will always involve bringing everyone to the table and will never involve disenfranchisement. The formation committee admits the purpose of the council is to give a voice to the voiceless as classes of stakeholders other than the low income voters already have other avenues to make their voice heard. Giving a voice to the voiceless is a laudable goal but the methods are flawed. A wide coalition would have certainly never signed off on bylaws that gives one individual a lifetime position with a an officially recognized government body. This provision certainly won't stand as we don't do that in this country, but it demonstrates that a large number of people did not participate in the formation of this council.

I support a Skid Row Neighborhood Council, but not this Skid Row Neighborhood Council. The status quo of the us vs them mentality has not worked for decades and the mechanics of this council will continue to do the same. I urge everyone to vote no in this election but to give it a look if Skid Row chooses to reapply with everyone involved.
