

I received the three contract duplicates today. The following items needs to be addressed:

1. The contract duplicates were only signed by one officer of the organization. The contract needs to be signed by two (2) officers of your organization. Please let me know if you'd like to pick up the contract duplicates from City Hall or if I should mail them to: 209-211 West 5th Street LA CA 90013.

2. Proof of Insurance - Proof of insurance on file in the City's track4la system begins on 05/01/15. However, the contract start date is 01/01/15. Proof of insurance for the entire time period of the contract is needed. Therefore, please have your insurance provider submit proof of General Liability insurance to cover 05/01/14 - 05/01/15. (See Form 146 - the last page of the contract for details.)

3. LABAVN - There are two contract ordinance related requirements that must be fulfilled via the online Los Angeles Business Assistance Virtual Network (LABAVN) system at <http://www.labavn.org>. I could not find either of the two items in the LABAVN system: Equal Benefits Ordinance and Equal Employment Opportunity. Please print and complete these forms and then resubmit them to the system.
