Hi, Scott,

Hope all is well. As Mike mentioned, assuming all documents are uploaded, we then verify and send the information to Everyone Counts (online voting vendor) to send you a username and password.

Online voter registration must end on April 2nd because our staff has to have enough time to verify all of the registrations in order to provide voters with a username and password for them to vote before 7pm on April 6th.

All stakeholders have to register and provide an address. Homeless people only need to self affirm their information and not provide further documentation if they do not have them. Online voter registration is only for those with documentation. Homeless people who are affirming must vote in person at the poll on April 6th. This policy has been in effect for Neighborhood Council elections the past 4 election cycles.

My staff is following up with you on your voter registration now as I understand that you did not provide all of the necessary documentation to register online.
