In order to conduct the email search, if nothing comes up with a search for "lacity.org <<http://lacity.org>> ", then you can ask him to specify the names of the city staff. You may also be able to ask him to limit the search by a particular topic and not a blanket "all intra-board emails." Your legal adviser will help you with this to ensure you are in compliance with the law.

Regarding the request for public records, yes, you do need to make the communications available. The BID is required, under the law, to adhere to the California Public Records Act. A response is required within 10 calendar days, at which time you may ask for an extension of an additional 14 calendar days. Anything beyond that will need to be discussed with [REDACTED]

Some communication may be exempt from disclosure. You must discuss the request and the communications with your legal adviser.

I realize that this request is likely to encompass a lot of material, so if you could give me access to it in tranches as it's prepared I would appreciate it very much.
