GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:										

The offense occurred in Washington, D.C. on Sunday, April 5, 2020. At approximately 1530 hours until approximately 1930 hours, a large group of All-Terrain Vehicles (ATV) riders were observed illegally operating ATV's on public space, throughout the District of Columbia. On April 5, 2020, multiple calls for service, throughout the District of Columbia were received by the Office of Unified Communications. The calls for service were placed in regards to the large group of ATVs being operated, causing a public nuisance, impeding the flow of traffic and placing the motorists and pedestrians in harm's way. During this period of time, your Affiant was able to obtain photographs of the group of riders as they illegally operated their ATVs and dirt bike on public space, throughout the District of Columbia. The group was estimated at over 150 ATVs being illegally operated throughout the city.

Your Affiant viewed the photographs and assigned each individual subject a number for organizational purposes. Subject #141 is described as a black male with a light complexion, thin build, [REDACTED] Subject #141 was photographed operating a predominately white and blue ATV. Subject #141 was photographed in the 2400 block of Hartford Street SE, DC at approximately 1540 hours, as he made a right hand turn onto the 3000 block of 24th Place SE as he operating the aforementioned vehicle. During this time, Subject #141 was photographed doing a "wheelie". This action is further
