GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:																											

The offense occurred in Washington, D.C. on Sunday August 4, 2019. At approximately 1700 hours until approximately 2000 hours, a large group of All-Terrain Vehicles (ATV) riders were observed illegally operating ATV's on public space, throughout the District of Columbia. On August 4, 2019, multiple calls for service, throughout the District of Columbia were received by the Office of Unified Communications. The calls for service were placed in regards to the large group of ATV's being operated, causing a public nuisance, impeding the flow of traffic and placing the motorists and pedestrians in harm's way. During this period of time your Affiant was able to obtain photographs for the group of riders as they illegally operated their ATV's and dirt bike on public space, throughout the District of Columbia.

Your Affiant viewed the photographs and assigned each individual suspect a number for organizational purposes. Subject #6 is described as a black male, thin build with a light complexion, long dread locks tied back [REDACTED] full beard, wearing a [REDACTED] and [REDACTED]. Subject #6 was photographed operating a predominately white and blue ATV. Subject #6 was photographed at approximately 1957 hours as he operated the aforementioned dirt bike in a northbound direction in the 2400 block of Minnesota Ave SE. The Defendant was in the left hand lane in the 2400 block of Minnesota Ave SE, while your Affiant was positioned in the right hand lane. Subject #6 exited the left hand turn lane and drove behind your Affiant and passed your Affiant on the right hand side. During this time, as Subject #6 operated the aforementioned ATV, Subject #6 was photographed with both legs extended over the front plastic fenders of the ATV. The position of the riders' legs and feet were away from the gear shift, with Subject #6 operating the ATV in a reckless manner as he did not have complete control over the ATV.
